ACT ICT to Gather Citizen Input Executive Women International Wichita Chapter January 15, 2014 Botanica

The City of Wichita has launched ACT ICT, a process that provides an opportunity for any group in the community to host a meeting where individuals will provide input into the community's future.

During these community engagement meetings, a facilitator will take the group through a process where each person will provide his or her vision of the community, assign priorities to the issues facing the community, and give input to preferred methods of funding.

"Our community, like many others, has limited resources and we will be making decisions that will affect us for generations to come." "We know that people are busy and it's challenging to have discussions about public funding that are representative of our diverse community, so we often hear just from a few people. We're eager to hear from a wide range of citizens" said Mayor Carl Brewer.

The City of Wichita worked with the Hugo Wall School of Urban and Public Affairs at Wichita State University to develop a presentation, feedback system and facilitators to respond to group requests. The Hugo Wall School will then provide a report on the collective input to the community, elected officials and community leaders.

<u>The Wichita Chapter of EWI</u> will have an opportunity to take part in this process at our January Meeting. The meeting is scheduled for January 15, 2014 at Botanica. This is an excellent opportunity for our Executives and Representatives to give input about the Community we all support.



When asked the question....

"What qualities are shared in the people you admire?"

- "In it for the greater good." The work they do, even if it pays well, is not about the money, it is about making things better.
- Humane. They recognize the value of being human.
- Forgiving of mistakes. We all make them; how we respond is more important than whether we made a mistake.
- Able to laugh and move on when dealing with problems. Keeping a sense of humor about oneself and one's situation is important.
- Goal directed. Accomplishing something important is in their DNA. Important may involve helping a single child learn to read or developing plans for saving the American economy. The goal does not have to be big, but it does make a difference and therefore it is important.
- Willing to teach. We all have limited time on earth; teaching others, either formally or informally, is crucial. Some of the best teachers with whom I have worked were Boy Scout leaders who were blue collar workers. Other teachers had Ph.D.'s. The common element was the willingness to share knowledge. To be a good teacher, one has to have respect for, and value, others.
