A Message from the President

June is a time for pause from the everyday, vacate your mind of all of the negativity, and replace your pessimistic thoughts with dreams. The MK Mueller event fulfilled its mission by raising awareness of EWI, providing meaningful professional development, and providing a positive message. Embracing "The Habits of Happiness" and "Taking Care of Me" are principals to live with the rest of our lives. For me, not only have I made a point to be

grateful, but I have begun to dream about possibilities in my life.

Turning 50 must do something to you. Several weeks ago I began the process of evaluating my personal and professional priorities, and have begun thought about intentionality in my life. I am pages into the Life Planning Toolkit introduced to me over five years ago in my EMBA class. The life planning exercises help to elicit passion, positivity, and adventure into one's life by mapping personal priorities (mine are Spiritual, Work and Career, Health, Personal Finance, Family & Friends, Hobbies & Community) finding points of commonality in goals, but more importantly, helping to not allow importance in one area to eliminate possibilities in another without intentionally doing so. The toolkit discusses committing your goals and priorities to writing. It stresses it's importance in five key ways:

- 1. It will force you to clarify what you want.

- 3. It will help you to evaluate extraneous opportunities and how they will impact your priorities.
- 4. It helps to combat and overcome areas weakness outside resistance to your goals.
- 5. It enables you to see and celebrate your progress.

Life is hard, especially if you feel that you are working yourself to death, going nowhere meaningful. Consider MK's message, become intentional, and begin the process of "Taking Care of Me".


