# LCAM Reading Rally Update

EWI recognizes that for all of us, the future truly begins with one simple, yet compelling declaration: "Hey, I can read!" We also appreciate that a literate community fosters rewarding careers and invaluable connections.

In 1992, EWI adopted literacy as a Corporate initiative that is now highlighted annually at LCAM via the Corporate Reading Rally spearheaded by the Corporate Literacy Committee and the host Chapter.

The beneficiary of the 2015 Corporate literacy initiative was Emerson Elementary School. 311 students strong, Emerson Elementary is located just a few blocks north of downtown Tulsa.

During the "all student" assembly, EWI presented to Emerson Elementary special gifts of Lego Mindstorms robotics labs, a library book truck, an atlas stand, STEM (which stands for science, technology, engineering and mathematics) connections reference books, art connection reference books, and a cash donation which the school will use to purchase iPads. EWI of Houston donated three (3) very beautiful rugs which will be placed prominently in the all-purpose room of the school. We also celebrated the collection of more than 77,000 pages in books donated to the school from EWI chapters. The students were then able to "shop" from this assortment of books to take home for their home library. Each student received a draw-string bag. In total, EWI, LCAM sponsors, and other generous donors provided more than \$8,000 to make this gifting possible. Thank you to all who donated and sponsored.

Since September 23, Julie Brothers has received many writing contest entries from the students of Emerson Elementary. The winner of the writing contest was Deidra Shaw. Our congratulations to Deidra! Her picture and a copy of her essay will be posted to the ewiconnect website as soon as we have received those.

During the Memorial Appreciations of LCAM 2015, Leona Pappas, EWI of San Antonio, was inadvertently left off of the announcement. Our sincerest apologies for this oversight. We would like to share her love for this organization as noted in excerpts of her obituary below.

# In Memory of Leona Maude Pappas November 11, 1921-June 29, 2015

Retired Television Editor of the San Antonio Express. She was 93.

The family moved to San Antonio in September 1936, where Leona graduated from Thomas Jefferson High School in 1940. She was hired at the Express Publishing Co. in 1946 and enjoyed a 39-year career at the newspaper. She

She traveled to Europe and to three Olympic Games; interviewed stars like Bob Hope, George Burns, Dick Van Dyke, and Lucille Ball; played basketball with the Harlem Globetrotters; and attended ABC, NBC, and CBS functions in Los Angeles, New Orleans, Las Vegas, and New York. Leona developed the TV magazine that appeared in the Sunday newspapers for decades. She was awarded the Texas Communicator of Achievement Award in 1997 by Texas Press Women, was named a Headliner in 1979 by Women in Communications, and was listed in the fourteenth edition of Who's Who in the South and Southwest. She retired from the Express-News in 1985.

Leona dedicated much of her unlimited energy and enthusiasm to Executive Women International (EWI) for 57 years. In 1958, when a chapter of EWI (formerly called Executive Secretaries, Inc.) was formed in San Antonio, 36-year-old Leona attended the first meeting as the representative for chartering member firm San Antonio Express & News. She jumped whole-heartedly into EWI. She served on most committees and held most board positions, serving as President of the San Antonio Chapter in 1966. She also served on the international EWI Membership Committee and represented the San Antonio Express-News at seven annual meetings. Her two most prized awards received from EWI were The Chapter's M.V.P. (Most Valuable Person) in 2006 and Chapter Life Member (the highest honor EWI can bestow) in 2009. Up until a few months before her passing, Leona was still faithfully serving on committees and attending meetings of her beloved EWI Chapter. Despite not having a driver's license, she seldom missed a chapter meeting. In fact, she had perfect attendance most years. Leona was an inspiration and encouragement to many EWI members. She encouraged and inspired others to step beyond their comfort zones and face challenges in business and personal endeavors. Leona called EWI one of the loves of her life, saying, "EWI has brought me joy and happiness and taught me about the business world. It helped me to grow my career. I just can't tell you how much I have learned through my membership."
