As promised, this month I want to share the consolidated results from the membership survey we conducted this fall; specifically the three key questions we asked you for input on.

# **View the Survey Summary**

As I reported in a recent blog, when asked "What keeps you involved in EWI?" the majority of respondents listed Connections first, then Careers and then Community. This is wonderful to see as it endorses our focus on building membership through a concerted focus on recruitment at the Chapter level. Twenty Mile Marching! It also reconfirms that our tag line of the 3 C's is still relevant and that they are listed in the correct order. When we talk about the return on investment (ROI) of EWI membership it is critical to focus on the "Connections" firms and their representatives can make as a member of EWI. Click here to download a new, updated postcard for your use when explaining the benefits.

The second key question we asked was, "How did you get involved in EWI?" Again, the responses indicated that we are on the right track if we focus on recruiting the firm and not the individual representative. One of the new key marketing pieces we are working on is the Annual Report, which will be distributed to all members and their Executives later this month. It is our belief that this e-zine will be a key marketing tool for your recruitment efforts.

The last question we summarized results for was "How could EWI better serve the membership?" The number one initiative you indicated was Marketing/Webinars. I am thrilled to advise that several of our current initiatives are focused on marketing the EWI brand to a greater extent. In addition to the newly revamped recruitment materials and the Annual Report, the office staff is looking at new, inexpensive software that will help us to create a marketing video for our collective use. In addition, we are focusing on forming strategic alliances with the goal of leveraging our philanthropic efforts for greater brand awareness. What we do collectively for literacy, be it Business Literacy (Academy of Leadership), Scholarship Programs (ASIST, EWISP and Fellows), or Reading Rally's, EWI needs to be identified as a premiere supporter of literacy initiatives. "Community" is one key differential of EWI that we must market more aggressively, thereby bringing increased awareness to "Connections" and "Careers".

The B/C/DP Committee, along with the Board have been focused on choosing a new "Doing Business As" name for B/C/DP and the final selection was "The Executive Women International Foundation". By rebranding this critical arm of our organization we can better articulate and leverage our philanthropic efforts. One of the first tasks for our new Executive Director will be to develop a comprehensive marketing plan for the Foundation; strategic partnerships at the corporate level that will also ease Chapter operations for philanthropy, dedicated web presence, increased benefits and offerings for our Alumni members and our highly anticipated launch of offering Academy of Leadership to all of our members via an online learning application.

In so far as better corporate communication is concerned, we have reverted back to the Connect template with Director Reports for better sharing of our initiatives while also continuing on with the monthly Leadership Connect issue. I am also blogging weekly in the hopes of sharing information more rapidly. call in February for all members to participate in. This will be, in essence, a virtual Town Hall meeting. If there are other avenues of communication you would like to see us utilize, please don't hesitate to let us know. The board members and I are always just a phone call away!

Chapter Development is also a key area you have indicated that we need to focus on. Kim Fankhauser, Expansion Committee Chair and her team are working diligently on several initiatives, including two new potential Chapters in Canada. I have also just been contacted by a young lady who is a past recipient of a EWISP scholarship. She would like to establish EWI groups not only on her own college campus, but on campuses throughout North America. We are also keenly focused on the MAL membership classification and developing product offerings that support the "Career" mandate for them, i.e. Academy of Leadership online. This month I hope to meet with the Executive Director and President of International Executive's Association to discuss a strategic alliance. They currently have 110 Chapters, some in cities where we do not currently exist and visa versa.

Last, but certainly not least, is that you indicated we need to reduce the cost to attend LCAM. I am happy to report that this year we will not be including a mandatory Academy of Leadership module in the registration fee. An optional AoL module will be offered. Of note here is that we will be launching a new module at Spring Conference in Chattanooga, April 18-20<sup>th</sup>. The new module is "Emotional Intelligence and Leadership - Making the Connection".

In closing, I would like to make another plea to the membership for those interested in corporate committee service to step forward and let me know. We are in desperate need of a Vice-Chair for Member Retention, working with Jenni Burns, EWI of Phoenix, who is our Member Services Chair. In addition, we still need volunteers to serve on a variety of committees. If you are thinking of trying corporate service this is an excellent starting point and usually only requires one conference call a month, plus whatever take-away items the committee is working on. Is it time for you to learn a new role within EWI? We would love to support you in this goal.

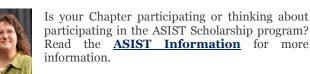
