This month marks the 35th anniversary of Women's History Month and this year's theme, "Weaving the Stories of Women's Lives" reminds me how important it is to share our stories and keep them alive. The stories of women's lives, and the choices we make, will encourage future generation of girls and young women to think larger and bolder, and give boys and men a fuller understanding of the female experience. There is real power in hearing women's stories, and we do that so well in EWI, from telling the story of EWI founder Lucille Johnson Perkins to inviting women leaders to share their experiences at our chapter meetings, just to name a few.
