President's Message



As the board moves into its fifth month of leadership, we are working together to identify some of the missing links from our rich EWI history. As a board, we have learned a lot and have a lot to still learn about our Wichita Chapter. One of our goals this year is to capture those missing links for our incoming leadership team. By identifying the best practices of our chapter, and compile tips and tricks for serving on the board in each director's respective role, we hope to encourage members to serve on the board to instill confidence

in their ability to lead without fear. Equally important has been to preserve the history of how our organization has been so successful since 1970 while implementing new improvements along the way.

Missing Links

From the survey and through the speed dating process a theme that surfaced was that over the years, and through the transition of several boards, historical information is not being retained or transferred sufficiently. Some examples uncovered this year include the BCDP endowment, the Investment Committee's role, and our Chapter Bylaws.

To mitigate greater information loss, the board is taking strides to improve this information retention by 1) tweaking the corporate job descriptions for their respective roles to be in alignment with how the role "manifests" itself in our chapter; 2) creating a bulleted list for "information" that is helpful to know; and 3) creating an online document repository.

New Improvements

One area that I have discussed with the board this year, is to consider the creation of a task force that would be responsible for helping our organization become a member-centric organization. While still in its infancy stage, I would see this task force's initiative to take the key messages from the survey and speed dating exercise to build value groups in our Wichita Chapter based on what our members enjoy about EWI.

Peanut Butter Fingers

Mix together:

1egg

1/2 Cup butter (1stick) 1/2 Cup Sugar

1/2 Cup Brown Sugar

1/3 Cup Peanut Butter 1teaspoon Soda

1/4 teaspoon Salt

1/2 teaspoon Vanilla

After well blended add:

1Cup Flour 1Cup Oatmeal (old fashion)

Spread in greased 9X13 pan

Bake at 350° for about 20 to 25 minutes (light brown - do not over bake)

Remove from oven and sprinkle with 1 package (12 ounces) chocolate chips.

Put back in the oven to soften (not to melt) the chips (about 2 minutes)

Remove from oven and smooth out the chips - Let cool

Frosting:

1/2 Cup Powder Sugar 1/2 Cup Peanut Butter 2 to 4 Tablespoons of Milk

Spread over the chocolate chips

Cut into bars





Unique membership benefits to the Wichita Chapter

Did you know that the majority of EWI chapters in our region assess monthly fees to all of their members for chapter meetings unless the member notifies the Sergeant-At-Arms in advance that they are not attending? While this practice simplifies bookkeeping and reduces errors, the Wichita Chapter maintains that this practice doesn't service our membership or provide that extra value and convenience of being part of our organization. It is with this in mind that I would like to illustrate a few very important messages on how you can help.

Pay by Account – What does it mean and how does it impact me

Our members are provided 4 options to make payments towards monthly chapter meetings with two of those options that play hand-in-hand. Members have the option to pay a "lump" sum amount that is credited (or applied) to the representative's general ledger account. As the member attends meetings and selects "pay by account" monies are deducted (or debited) to that representative's general ledger account to generate an account balance either in the positive or negative.

The other two options are fairly simple in nature and are processed on the representative's general ledger after the payment is processed. Due to the slight delay in processing payments, the board is implementing a 60 day past due notification that will be sent via email to representatives, from PayPal, when their account has fallen past due. If you receive a notification from Executive Women International with a subject line of "You have received an invoice..." it is likely because your account has fallen behind. Thank you to Tami Barker, S@A and Davna Gould, Treasurer for the dedication to serving EWI and getting accounts in a stable state while creating a process that is more conducive to a professional organization.
