Several other takeaways were:

- You only have to keep personal tax returns for 3 years
- To make sure you are withholding enough money this year for your 2018 return, go to: www.taxchanges.us for a W4 check. Because of changes, you may have to increase your withholdings.
- There have been a lot of changes to tax laws this year. To check them out go to: www.taxpayeradvocate.irs.gov/taxchanges
- The Taxpayer Advocate Service (TAS) is your voice at the IRS. They are an independent organization within the IRS and have a local office. Their mission is to help taxpayers resolve problems with the IRS, will recommend changes that will prevent problems and to help individuals whose tax problems are causing financial difficulty. Their services are free.

Identity Theft Information for Taxpayers

Identity theft places a burden on its victims and presents a challenge to many businesses, organizations and governments, including the IRS. The IRS combats this crime with an aggressive strategy of pravention, detection and victim assistance.

What is tax-related identity theft?

Tax-related identity their occurs when someone uses your stolen Social Sociarity number (SSN) to title a tax return claiming a fraudulent refund. If you occurs a victim, we are committed to resolving your case as quickly as possible.

You may be unaware that this has happened untilyou e-file your return and discover that a return afready has been filed using your SSN. Or, the IRS may send you a tester saying it has identified a suspicious return valog your SSN.

Know the warning signs

Be alert to possible tex-related identity that if you are contacted by the IBS about:

- More than one tax return was filed for you,
- You owo additional tax, have a refund offset or have had collection actions taken against you for a year you did not till a tax return, or
- IAS records indicate you received wages or other income from an employer for whom you did not work.

Stops for victims of identity theft

If you are a victim of identity that, the Federal Trace Commission reconstructs these steps:

- File a complaint with the FTC at <u>identifytheit cov.</u>
- Contact one of the three major credit bureaus to place a 'fraud e'ert' on your credit records:
 - www.Equifax.com 1-888-766-0008
 - vavev.Experian.com 1-868-397-8742
 - www.transtinion.com 1-800-660-7289
- Close any financial or credit accounts opened by identity thieves

If your SSN is compromised and you know or suspect you are a victim of tax-related identity theft, the IRS recommends these additional steps:

- Respond immediately to any IRS notice call the number provided or, <u>if instructed</u>, go to IDVerify, its.gov.
- Complete IRS Form (<u>4039</u>, <u>Klentin' Theft</u>
 <u>Attitudit</u>, if your o-file return rejects because
 of a duplicate filing under your SSN or you are
 instructed to do so. Use a fill abla form at
 IRS.gov, print, then attach form to your paper
 return and mail seconding to instructions.

- Continue to pay your taxes and file your tax return, even if you must do so by paper.
- If you previously contacted the IRS and did not have a resolution, contact us for specialized assistance at 1,800,909-4490. We have teams available to assist.

Not all data breaches or computer hacks result in tax-related identity that, it's important to know what type of personal information was aloren.

Now you can reduce your risk

Join efforts by the ISS, states and tax industry to protect your data. <u>Taxes. Security. 'foodther</u>, We all have a role to play. Here's how you can help:

- Always use security software with trowall and anti-virus protections. Use strong passwords.
- Learn to recognize and swold phishing emails, threatening calls and texts from thieves posing as legitimate organizations such as your bank, credit, card companies and even the RRS.
- Do not click on links or download attachments from unknown or suspicious isnails.
- Protect your personel dett. Don't routinely carry your Social Security cond, and make sure your tax records are secure.

Security Awareness For Taxpayers

TAXES. SECURITY, TOGETHER.

The IRS, the states and the tax industry are committed to protecting you from identity theft. We've strengthened our partnership to fight a common enemy – the criminals – and to devote cursalves to a common goal – serving you. Working together, we've made many changes to combad identity theft, and we are making progress. However, cybercriminals are constantly evolving, and so must we. The IRS is working hand in hand with your state revenue officials, your tax software provider and your fax preparer. But, we need your help. We need you to join with us. By taking a few simple steps, you can better protect your personal and financial data online and at home.

Please consider these steps to protect yourselves from identity thickes:

Keep Your Computer Secure

- Use security software and make sure it updates automatically; essential tools include:
 - Einemorall
 - Virus/malware protection
- File encryption for sensitive data
- Treat your personal information like cash, don't leave it lying around
- · Check out companies to find out who you're really dealing with
- Give personal information only over encrypted websites -- look for "https" addresses.
- Use strong passwords and protect them
- Back up your fles

Avoid Phishing and Malware

- Avoid phishing smalls, texts or calls that appear to be from the IHS and companies you know and trust, go directly to their websites instead
- Don't open attachments in emails pintess you know who sent it and what it is
- Download and Install software only from websites you know and trust
- Use a pop-up blocker
- · Talk to your family about safe computing

Protect Personal Information

Don't routinely carry your social security card or documents with your SSN. Do not overshare personal information on social media. Information about past addresses, a new dar, a new home and your children help identity thieves pose as you. Keep old tax returns and tax records under lock and key or encrypted if electronic. Shred tax documents before trashing.

Avoid IRS impersonators. The IRS will not call you with threats of jail or lawsuits. The IRS will not send you an unsoficited email suggesting you have a refund or that you need to update your account. The IRS will not request any sensitive information online. These are all seams, and they are persistent. Durit fall for thorn, Forward IRS-related seam emails to obishing@irs.gov. Report IRS-impersonation telephone calls at www.ligita.gov.

Additional steps:

- Chock your credit report annually; check your bank and credit card statements often;
- Review your Social Security Administration records annually. Sign up for My Social Security at www.ssa.gov.
- If you are an identity that, victim whose tax account is affected, review www.irs.cov/identitythat; for detalls.
