



Fun facts to understand the broader EWI organization.

EWIGA stands for Executive Women International Global Alliance. It is the name of the parent company for all EWI entities.

EWIGA is governed by the EWIGA Board of Directors and EWIGA Bylaws. The EWIGA Board of Directors consists of the Corporate Board of Directors.

So what is it and why does it exist?

Several years ago EWI had inquiries from some ladies in other countries who were interested in becoming members of EWI. Unfortunately, the laws for those countries differed from our laws here in the US. In order to be able to include these affiliates under our EWI umbrella we had to create a new entity with its own bylaws. We wanted the affiliates to follow the principles of EWI along with our branding and marketing, etc., but needed to be able to adapt to the laws of other countries. In order to do this we had to create an entity that had all the power to grant rights and licenses internationally. EWIGA was created in October 2003. Since that time all of those international affiliates have dissolved, but its existence allowed us to add the Collegiate arm of EWI.

The reason the bylaws are different from what we vote on at LCAM is because they are broad enough to allow the Board of Directors the authority to be able to expand outside of US or Canada and do something different like our Collegiate Chapter - they do not fall into our bylaws as they do not always have firms etc. We say they are the parent company because of the power to grant and license other entities. We did not want to dissolve this entity because we may need it in the future. At this time these affiliates have no voting rights but are overseen by the Board to ensure they are complying.
